# Dr. Marie Feltin



Dr. Marie Feltin found her way to Boston via Montreal and McGill University after being born in Nazi-occupied France, and christened under an assumed name to avoid the terrors of the Holocaust because she was Jewish. She was a product of the 1960s and the idealism and flamboyance of that era, having a universal love of dance, the flute, piano, and conga drums. Marie's life was never compartmentalized; work, pleasure, family, and friends were interwoven in seamless fashion. What she left behind is a direct result of who she was and where she came from in life.

Marie saw people with disabilities' strong desire and ability to live independently and she viewed "empowerment" as not just an abstract ideological goal but as a practical strategy to promote health and function. Marie and her staff returned to home visiting to provide medical care, recognizing how difficult it was for many of her patients to make the trek to the doctor's office or to the clinic, and she felt that home care broke down the barriers that existed between clinicians and the lives of their patients. Marie, according to Dr. Susan Bennett, had a "willingness to take care of people who are sick and poor and old, but she did not do that with any sense of it elevating herself. She did it with complete humility."

Marie was always available for her patients. Her beeper would go off constantly and she would always respond quickly but calmly. Jean Masland, director of the long- term care services at East Boston Neighborhood Health Center, sums up the feelings of those who knew Marie as a physician: "She really touched patients a lot—I mean physically and emotionally. Her patients always wanted to hug her. She liked that." In her personal life and in her work, she was very humble and very spiritual.

There are many memorials left behind by Marie that withstand the test of time and continue her legacy in both the medical field and in life in general. Founder of the East Boston Health Center's Home Care Program, Boston's Community Medical Group, and the Urban Medical Group, she was a modern-day pioneer in providing medical care to society's most neglected and vulnerable populations. She broke down barriers that often existed between patient and physician and medical care staff such as nurses and nurse practitioners. She saw her job with other medical personnel as a task of total devotion with no separation because of job title or function.

Supported in these endeavors by her husband, Dr. Robert Master, and their children, Daniel, Johanne, Steven, Jonas and Sarina, Marie overcame many obstacles to attain her goals, though she was unable to overcome the illness that took her from us in 1994. The Boston Center for Independent Living is proud to be the sponsor of this twenty- sixth annual award ceremony in memory of Dr. Marie C. Feltin. The ceremony, the brainchild of the late Sergio Goncalves, is held to carry on the work started by Marie to empower individuals with disabilities to take control of their lives and live independently.

A founder of the Boston Community Medical Group, the Urban Medical Group, and the East Boston Health Center Homecare Program, Marie focused on serving neglected and vulnerable populations. Her hands-on care and the medical institutions she created empowered patients to become actively involved in their care as a critical means to bettering their health.

# Senator Lydia Edwards

Senator Lydia Edwards is a career advocate, activist and voice on behalf of society's most vulnerable. She was raised all over the world by her military mom but chose to make East Boston her home.

Prior to being elected to the State Senate and Boston City Council, Lydia worked extensively in the legal field. She worked as a public interest attorney with Greater Boston Legal Services focusing on labor



issues such as fighting for access to unemployment insurance, back wages, fair treatment for domestic workers, and combating human trafficking.

Additionally, she coordinated a statewide campaign to pass the Domestic Workers Bill of Rights - and she won. Following the bill's passage, she was named Bostonian of the Year, Honorable Mention, by the Boston Globe.

As a City Councilor, she led efforts to protect Boston's affordable housing stock through innovative and bold policy proposals. She spearheaded reforms to Inclusionary Development and Linkage and passed through the council a real estate transfer fee on the sale of properties valued at over two million dollars, with all proceeds dedicated to affordable housing.

Lydia pushed to reduce airport pollution, expand water transportation, address traffic congestion, ensure community voice in major energy projects, rebuild public housing and stop proposed highway expansion. She solidified her role in the community as a bridge-builder, convening and organizing community meetings to take on larger conversations like Suffolk Downs in East Boston, the Bunker Hill Redevelopment project in Charlestown, and climate resilience in the historic North End.

She spearheaded the effort to get the city's charter amended and democratize the three billion dollar city budget through participatory budgeting. Lydia advocated for greater transparency in city government while maintaining fiscal responsibility. She has fought to reform the Zoning Board of Appeals to reduce influence-peddling in the development process. Lydia fights for a Boston that works for everyone.

Her job title may change, but her values never have. Lydia Edwards has always been on the side of the underdog- and she's found new ways to make change at each new role.

My name is **Gwendolyn Brown.** I'm an energetic outgoing person, and I love being outdoors to enjoy the fresh air. Hiking, water tubing, and ziplining are just a few of the activities I enjoy. I also love to dance and laugh as a form of meditation and therapy for myself. I am a proud mother, grandmother, and great grandmother to my three children, six grandchildren, and my two-year-old

great grandson. My two wonderful sons are 42 and 40 years old, and they both have their own beautiful families. My beautiful daughter Nevaeh is 20 years old, and she is in her sophomore year at Salem University.

Being a mother has given me the ability to understand how important it is to provide quality care and a safe environment for your children and loved ones. As a caregiver, allowing people to have the opportunity to live in their homes, easing the minds of their loved ones, and providing them with respect and dignity is important to me. I embrace each consumer and their families as if they were my own. I've always felt that as a caregiver, it's not just about doing a job. It's about creating joyous smiles, hearing laughter, and seeing that through my work I am able to provide happiness and comfort. That's the true show of an outstanding caregiver. My goal is to always be an advocate for those who can't raise their voices. I feel that helping others and making people happy is not just a passion for me, it is my purpose in life.



I am **Ruiyi Tan**, and I have worked as a personal care attendant (PCA) for 13 years. For the past 11 years, I have been a PCA for Medical Resources Home Health Corporation. Six years ago, my colleagues and I decided to unionize, making Medical Resources Home Health Massachusetts's first unionized personal care service provider.

At the start of the pandemic, more than two years ago, the world seemed to come to a standstill. We all lived in fear as the virus threatened our lives. The impact of the pandemic across industries is unimaginable, but especially so for front-line workers in the personal care and service industries. Not only do these front-line workers need to take care of their own families and themselves, they also risk their lives to take care of their clients' health and livelihoods. Many elderly people, who could not properly care for themselves during this pandemic, passed away due to insufficient care. As a result, many families have lost their loved ones. Some families did not have the chance to say good-bye or see their loved one one last time. This tragic and regrettable loss highlights the significance of the personal care industry.

The impact of the pandemic is even greater on low-wage workers. Working families are facing many pressures from soaring prices, rising rents, increasing medical expenses, and more. The plight of the working-class person is not just my own. Many working-class families face the same difficulties. Despite reaching retirement age, I have no choice, but to continue to work. In fact, I work four jobs just to make ends meet. The need to raise wages and improve the lives of workers and their families is urgent. Only when ordinary working people's lives are improved can our society move towards equity and true progress.



Maria Alejandra Alessio has been working with children, adults, and seniors with disabilities for over 10 years. She has watched the people she serves grow to be confident and independent by providing an environment that includes compassion, structure, and guidance. She has the honor of working with the union, 1199SEIU,

which has allowed me to assist my fellow co-workers and beyond." She comes from a diverse family that includes individuals with disabilities. "They were my first inspiration to have a career in healthcare."

# Honoree

### Taciana Ribeiro-Saab

**Taciana** serves as Program Manager for BCIL's recently opened satellite office in Dorchester and has been leading the organization's antiracism efforts for the past two years. She also oversees the Information and Referral Department and is working with her team to increase outreach and services to Boston's Black, Indigenous and People of Color consumers.



Taciana came to the United States as a young woman who had to flee domestic violence with her then 2-year-old son, Cristian. She resettled in Northampton, MA where she pursued her studies in Social Thought and Political Economy at the University of Massachusetts Amherst. She then moved to Boston and pursed work in organizing and welfare reform for many years, while being an active member of Latinos for Social Change and the Brazilian Immigrant Center. The shift to working with people with disabilities came after the tragic loss of her then 18-year-old son in 2004. Cristian was killed during a robbery at a local retail store where he worked after school.

Cristian's tragic death propelled Taciana into action for changes of workplace safety regulations. She joined forces with teen leaders of the Massachusetts Coalition for Occupational Safety and Health and the Brazilian Immigrant Center. After conducting research on work conditions for teens at several Boston retail locations, they proposed several changes to workplace safety, training for teen employees, reduced work hour schedules, and proper supervision during night shifts. This legislation was signed into law by then Governor Mitt Romney in 2007 – the Child Labor Reform Act. Taciana has devoted her life to fight for social and economic justice for people of color and sees BCIL's antiracism efforts as an extension of her life's work. "The fight for racial justice is deeply personal to me. As a parent who lost a son during a robbery, killed by a man who was stealing to feed a drug addiction, and a parent of a young Black man, I see the intersection of race and disability as crucial to creating a better society for all of us." Taciana's own struggles with mental health issues, and difficulties of getting a correct diagnosis and proper treatment, contributed to the urgency of her work.

Taciana has invested the last two decades of her life creating pathways to careers for people with disabilities, new Americans, and other underserved populations. In recent years, Taciana partnered with local public schools, community colleges, credential training partners, and employers to create Credentials to Careers Initiatives in the Culinary Arts and Allied Health Field for youth and adults with disabilities.

Taciana is a highly skilled program developer who also has experience creating credential bearing pathways for people in the early childhood education and hospital industries. In her previous role as Workforce Development Director at Triangle in Malden, Taciana launched successful innovative workforce development programs and enhanced existing DDS and MRC funded services that catalyzed the careers of hundreds of individuals with disabilities.

# Honoree Dan Manning



**Dan Manning** is the Director of Litigation for Greater Boston Legal Services. He started his legal aid career as a law student in 1971 at the Fields Corner office of the Boston Legal Assistance Project (now GBLS) and has been representing lowincome people ever since. He has worked on cases involving housing, immigration, family law, welfare rights, consumer, employment, and, for the last 25 years, he has focused on the rights of people with

disabilities. He has been involved in litigation against virtually all state agencies serving poor people and several major federal agencies as well.

Dan is very proud of his collaboration with BCIL on many issues. In 2002 he and his colleague Tara Doucette partnered with community members to take on the problem that people with disabilities were constantly being denied access to buses and subways in Boston. Together they filed the case of Joanne Daniels-Finegold v. MBTA, in which BCIL was an organizational plaintiff. After vigorous litigation, hard hitting grassroots advocacy, and intense negotiations, this landmark ADA class action lawsuit was settled in 2006, resulting in opening up the system to everyone.

Dan has also worked with BCIL on access to healthcare. While he believes that litigation can help solve problems, he thinks the best solutions come when individuals and advocacy organizations engage directly with institutions to provide full access and benefits to people with disabilities. One of his proudest moments was playing a supporting role for eight individuals and BCIL when they met directly with the presidents of Mass General Hospital and Brigham and Women's Hospital to explain why their institutions were not serving people with disabilities the way they should. This was followed by very detailed agreement for major improvements in access to care at the hospitals. Both presidents said the meeting with the group made all the difference. This work also led to a similar agreement with Boston Medical Center.

While continuing to practice law in Boston, Dan had the opportunity to travel to South Africa soon after Nelson Mandela became president to work with legal aid organizations there who were working to dismantle the legacy of Apartheid. That experience led to work with other legal organizations around the world including in Bangladesh, Albania, Bosnia, China and Cambodia, among others. He continues to be inspired by the work he saw those organizations do under very challenging circumstances.

Dan and his wife Ellen are very blessed to have 6 wonderful grandchildren. He is an avid jigsaw puzzler and kayaker.






